

The Achieving Independence Center is a "one-stop" shop designed to support foster youth ages 14-22 that are aging out of the system. A comprehensive overview of services provided:

- Act 91 re-entry assistance
- AMPlify mentoring program
- Art and other creative industry workshops
- Coaching and case management
- Educational supports
- Employment assistance
- Healthy relationships classes
- Housing counseling and referrals to housing programs
- Individual and group counseling
- Life skills and housing classes
- Philadelphia youth network (PYN) summer jobs
- Philly works grant
- Preventative drug and alcohol counseling
- Sexual health counseling and testing
- Specific programming for 14-15 year olds (YAIC)
- Specific programming for 21-23 years olds (OAIC)

Language Access: English; call-in program if translators are needed.

**Referral Process:** The recruitment team must be provided the youth's name, date of birth, direct contact information, and DHS case number (if applicable). Further, there are 3 means of youth referrals to AIC: (1) ECMS referrals which are preferred by DHS (2) Emailing recruitment team at <u>referral@aicenter.us</u> (3) Calling recruitment team at 215-574-9194. Youth must be referred, proven eligible, and confirmed to attend a specific orientation date.

**Eligibility Requirements:** (1) Youth ages 14-22 (2) Out-of-home dependent placement after age 14 such as foster care, congregate care, or kinship (3) Youth discharged from care but who meet criteria 1 and 2 are still eligible to attend AIC (4) Youth with delinquent history may attend if it is court-mandated by a judge, however, will not be eligible for financial incentives (5) Youth who are in placement in another country but placed in Philadelphia may attend if they meet the above criteria and their case manager provides the required documentation.

The Attic Youth Center offers a wide range of services and programs in a safe environment for LGBTQ youth. As a LGBTQ youth center, Attic works to build community among LGBTQ youth and foster in them a sense of independence and citizenship. The Attic also promotes widespread LGBTQ acceptance in the community at large.

The Attic has grown into a nationally recognized, multi-service youth organization, and is now one of the largest community centers in the U.S. committed exclusively to serving LGBTQ youth and allies. Refer to Attic's website for the up-to-date calendar of groups and activities. Photo identification is not required to enter physical space. The following services are provided by Attic:

- Community Navigation Services --- The Attic's Navigator can conduct general assessment to help identify needs and link to resources related to housing options (immediate shelter placement or LGBTQ+ youth supportive housing programs); education, job readiness skills and assistance; medical and sexual health.
- LGBTQ+ Counseling Services --- includes individual and family therapy. Counseling services are free and insurance is not required; however, 3<sup>rd</sup> party Medicaid insurance can be billed. Telehealth virtual access during pandemic restrictions is available.
- Life Skills Center Programming --- The Attic's Life Skills Center assists LGBTQ youth in building the skills necessary to succeed in school, their jobs or careers, and the community. Programming includes weekly drop-in socialization activities (meet peers and staff and build community relationships) and support/discussion/action groups offered in the space and virtually with regard to current pandemic restrictions. Zoom meeting sessions are available during pandemic restrictions.

Language Access: English; non-English accessibility status subject to change.

Accessibility: Onsite space has a ramp to enter building and an elevator for access to upper floors.

**Referral Process:** Please refer to the contact information section above on how to make referrals or connect to The Attic.

**Eligibility Requirements:** (1) Youth and young adults 14-23 years of age (2) Identify as LGBTQ+ or an ally (3) Caregiver/parental consent for youth under the age of 14 to participate and based on assessment of needs or how programs/services could benefit youth.

Children's Crisis Treatment Center (CCTC) provides a wide range of behavioral health services to children and families to address the impact of adversity and the effects of trauma, such as physical abuse, sexual abuse, neglect, and exposure to violence, as well as other challenges that impact childhood development and functioning.

CCTC's programs for children and families include:

- Outpatient Services (ages 2-13)
- Outpatient Trauma Services (ages 18 mos. through 13)
- Therapeutic Nursery (ages 2.5 to 5)


**Referral & Information Process:** To refer a child for services at CCTC, please call the Intake Line at 215-496-0707 ext. 1445, where general information such as a child's demographic information, behavioral health needs, trauma history, developmental abilities, and insurance information is obtained to assess which CCTC program and services would be the best fit to meet the child/family's needs.

**Language Access:** CCTC has several bilingual (Spanish-English) clinicians on staff in our programs, and clinicians can also request interpreters through CBH, as needed.

**Eligibility Requirements:** Each program has its own requirements and can be assessed on a case-bycase basis. Please contact the Intake Line for more information.

The Adolescent Initiative at the Children's Hospital of Philadelphia (CHOP) consists of a multidisciplinary team and integrated system of clinical care, youth-centered research initiatives, training, and prevention for adolescents at-risk of HIV/AIDS.

The program provides comprehensive, interdisciplinary, primary HIV specialty care to aid and bring HIVpositive and high-risk adolescents into a trauma-informed environment where they can feel comfortable receiving healthcare.

In addition to HIV specialty care, the Adolescent Initiative provides HIV prevention services through their PrEP Clinic and prevention case management services at the Philadelphia Juvenile Justice Services Center (PJJSC). The program provides support in insurance navigation, readiness/adherence counseling, health literacy, STI screening & treatment, medical case management, and LGBTQ+ affirming safe sex supplies and education.

The Adolescent Initiative has been providing services for youth detained at the PJJSC since 2002 with the goal of improving sexual health outcomes for at-risk youth through one-on-one, individualized sexuality education, intensive case management, and linkage to medical care. The program specializes in working with young women and LGBTQ+ youth and can continue to support youth in the community upon their release, if desired.

**Referral Process:** Please contact the following departments for referrals. For preventative services for delinquent youth, please note that youth do not need to be in custody at the time of referral to be eligible for services, youth simply need to have DHS/Juvenile Justice oversight. While the program is currently not able to physically see youth at the PJJSC during the COVID-19 pandemic, the program is fully operational and is taking new referrals for services.

**Eligibility Requirements:** The Adolescent Initiative programs serve youth ages 13-24 years, addressing any barriers to receiving care, including transportation difficulties, insurance access, etc. The program specializes in working with young women and LGBTQ+ youth and can continue to support youth in the community upon their release from JJSC if desired.

The Child Abuse, Referral, and Evaluation (CARE) Clinic is a division of CHOP that provides medical evaluations of children and adolescents for possible sexual abuse, physical abuse, or neglect. The CARE Clinic is staffed with a team of social workers, physicians, and mental health clinicians who can perform physical examinations, STI testing, mental health evaluations, and pregnancy testing.

**Referral Process:** Call the Access Center at 215-590-4923. If unable to connect, you can leave a message with Christina McCloskey at 267-426-3111. Referrals are subsequently forwarded to the CHOP Suspected Child Abuse & Neglect (SCAN)/Child Protection Team.

Eligibility Requirements: The CARE Clinic typically sees youth up to the age of 19.

Community Behavioral Health (CBH) specializes in meeting the behavioral health needs of Medicaid-eligible residents. CBH is a non-profit corporation, managed by the City of Philadelphia. It is a division of the DBHIDS, which provides an array of mental health and substance abuse services to adults, adolescents, and children. There are many levels of care that WRAP Court children who are CBH members have utilized, including:

- Acute inpatient hospitalization (requires a psychiatrist recommendation)
- Acute partial hospitalization program (requires a psychiatrist recommendation)
- Children's mobile intervention services (requires a psychiatrist recommendation)
- Community integrative recovery center (requires a psychiatrist recommendation)
- Family based services (requires a psychiatrist or psychologist recommendation)
- Functional family therapy (requires a psychiatrist or psychologist recommendation)
- Inpatient drug/alcohol rehabilitation (requires a psychiatrist or psychologist recommendation)
- Intensive behavioral health services (written order)
- Intensive drug/alcohol outpatient program
- Medication management (requires a psychiatrist recommendation)
- Outpatient therapy
- Residential treatment facility (requires a psychiatrist recommendation)

Covenant House Pennsylvania (CHPA) is the largest provider of services to homeless youth in Philadelphia, serving runaway, trafficked, at-risk, and homeless youth ages 21 and under.

The mission of CHPA is to serve youth in crisis and "help homeless young people become healthy, happy, responsible, productive, and ultimately independent adults. Covenant House provides a continuum of services from Street Outreach to the Crisis Center that includes a 24/7 emergency shelter, health clinic, employment, education and vocational programs, and transitional living programs.

Each youth designs a goal plan with their case manager and checks in regularly about their progress.

By providing youth with basic fundamental life skills, Covenant House aims to aid youth to be prepared to make responsible and sustainable choices upon leaving their program and become productive members of the Philadelphia community.

Language Access: CHPA has a language line access through their CHOP Connections Clinic.

**Referral Process:** All youth are self-referred, with CHPA staff needing to talk directly to youth. Courts and parents cannot mandate a stay at CHPA.

**Eligibility Requirements:** CHPA serves all youth that are homeless, runaway, and/or trafficked that are 21 years old or younger. There are no status requirements. Male and female transgender youth are placed on the residential floor of the gender in which they identify. Insurance is not required. All CHPA services are offered at no cost.

The City of Philadelphia's Department of Behavioral Health and Intellectual Disability Services (DBHIDS) is part of the City's Office of Health and Human Services. DBHIDS offers behavioral healthcare, intellectual disability support and early intervention services in one comprehensive integrated system.

Guided by the vision and mission of DBHIDS, the Immigrant Affairs and Language Access Services Unit's mission is to improve the total wellness for immigrant and refugee communities through a holistic community-based engagement and service delivery approach.

The Immigrant Affairs and Language Access Services Unit assists in the development of agency-wide policies and strength-based approaches that engage and provide culturally and linguistically appropriate services for refugee and immigrant communities with behavioral health concerns.

DBHIDS also leads the Philadelphia Alliance of Child Trauma Services (PACTS), a network of child-serving systems and organizations that provides the most effective practices for traumatic youth and their families aimed to increase the number of children who receive the most effective trauma-focused and trauma-informed care in Philadelphia.

The Joseph J. Peters Institute (JJPI) serves survivors of trauma and individuals with a history of sexual or relational violence through the provision of high-quality, evidence-based social and psychological services, training, evaluation, research, education, consultation, and prevention.

JJPI employs evidence-based and evidence-informed outpatient therapy practices across all evaluations for trauma survivors of all ages. JJPI has a few clinicians trained in trauma-focused cognitive behavioral therapy (TF-CBT) for commercially sexually exploited (CSE) children.

All therapists at JJPI are trained in TF-CBT, providing an adolescent dialectical behavior therapy (DBT) program and an adolescent prolonged exposure therapy (pe) program. Similar to the DBT program, however in group formats, the trauma affect regulation: guide for education & therapy (TARGET) is also available to adolescents; the therapeutic program teaches skills that can be used by trauma survivors to handle present-day stress reactions, trauma, emotional states to reach lasting recovery.

Located at the Chestnut location, individuals can seek treatment at the Safety and Responsibility Program (SRP) site for sexual behavior problems and/or who have been charged/convicted with convicted sexual offenses. The Youth Safety and Responsibility Program (YSRP) serves adolescents (age 12+ years) who have problematic sexual behavior.

The Philadelphia Children's Alliance (PCA) is a regional child advocacy center that promotes healing and justice for child victims of sexual abuse. PCA coordinates child sexual abuse investigations among Philadelphia public agencies. PCA collaborates with partners in child protection, law enforcement, and medical and mental health services to provide forensic interviews, victim support, and counseling services at the Philadelphia Safety Collaborative, a co-located child-friendly facility. PCA offers CVHT therapy, court accompaniment, family/victim advocacy, and conducts CVHT assessments.

CVHT therapy consists of treatment modalities of trauma-focused cognitive behavioral therapy (TF-CBT) and/or eye movement desensitization and reprocessing (EMDR). There is also the opportunity to engage parents/caregivers in the child's treatment.

Under the Clinical Department at PCA, there is a CVHT Assessment Specialist that conducts assessments with children and youth who have been identified as being at-risk for commercial sexual exploitation and/or trafficking.

The CVHT Assessor position also works and collaborates with other community agencies such as DHS and CUAs to help youth connect to specialized supports and services.

**Language Access:** PCA uses language line as needed. During therapy sessions, an "in-person" translator is used via Zoom as needed – this option is offered when the language needed is not Spanish. PCA tries to keep the same translator for consistency, however, is most commonly used with caregivers who do not speak English but their participation in the child's therapy is vital. However, this is also available to the youth. PCA also has a bilingual Trauma Therapist as well as other bilingual staff who work with our Spanish-speaking families.

**Referral Process:** PCA's current referral sources are through internal and DHS referrals. To refer a child or youth that may have suspected concerns/red flags of being commercially sexually exploited and/or trafficked, a CVHT screening and assessment referral is sent to Manager of Clinical Services and CVHT Assessment Specialist. To refer for CVHT therapy, fill out the referral form in <u>Appendix B</u> and email it to Ricky Schermond. Ricky Schermond is also a point of contact for any questions/information regarding PCA's clinical services.

**Eligibility Requirements:** For CVHT therapy, the child/youth must have confirmed or strong suspicions of CVHT/trafficking, age mid-20s or younger, and any gender. There is no insurance or payment required as it is grant funded. During COVID-19, the child needs access to the internet via smartphone or computer (preferably) for the telehealth sessions. For a CVHT assessment, while there is no specific age range, typically, children and youth between the ages 7-18 years can be referred for a CVHT assessment if there are concerns/red flags of CVHT/trafficking; however, every referral can be discussed on a case-by-case basis. All services at PCA are free to families and PCA covers the cost for translation services.

The New Day to Stop Trafficking Program exists to promote safety for survivors of human trafficking and exploitation through supporting their strengths and offering accessible services to prevent re-victimization and enact social change in the Philadelphia region. Some services offered include:

- Mobile Case Management Program --- provides trauma-informed, survivor-centered clinical case management to youth and/or adult survivors of human trafficking to help them meet their self-identified goals.
- Peer Mentorship--- team of peer mentors with lived experience in trafficking and substance use offer support to survivors of trafficking.
- New Day Drop-In (NDDI) --- provides a consistent, safe, welcoming, and trauma-informed environment for women exploited by the commercial sex industry in the Kensington neighborhood of North Philadelphia. New Day believes that women are the experts of their story and aims to create a space where they can work towards reclaiming control over their lives.
- New Day New Home --- long-term transitional living program for young women who identify as victims of sex and labor trafficking.
- Police Assisted Diversion Program--- Individuals arrested for the crime of prostitution are diverted for social services rather than charges. Street outreach to those involved in commercial sex.
- 24/7 Anti-Human Trafficking Hotline and Response--- Hotline that offers technical assistance, crisis response, referrals, and safety planning for survivors and third-party professionals. Offers in-person response if a survivor is in need.

# CLEARING ARRESTS & CRIMINAL CONVICTIONS FROM YOUR RECORD

# Pennsylvania Law for Survivors of Sex Trafficking

### HOW IT WORKS

Your criminal record can be a barrier to getting a job, housing, and immigration status. It can also impact family law issues.

However, there is a Pennsylvania law that can help you clear your criminal record. The law applies to certain offenses that were committed by a victim of sex trafficking as a direct result of being trafficked. The law does not limit the number of arrests or convictions.

The following offenses may be vacated (or cleared) from your record:

- Prostitution
- Criminal trespass
- Disorderly conduct
- Loitering and prowling at night time
- Obstructing highways and other public passages
- Simple possession of a controlled substance

#### AM I ELIGIBLE?

You may be eligible if your arrest and conviction occurred as a result of being trafficked. Being trafficked means someone made you engage in prostitution through:

- Causing or threatening harm, physical restraint, or abuse of the legal process;
- Kidnapping;
- Taking or retaining property as coercion;
- Withholding documents and identification;
- Extortion;
- Fraud;
- Criminal coercion;
- Duress through threatening to use force;
- Debt coercion;
- Facilitating and controlling access to a controlled substance; or
- Employing tactics intended to make you perceive a threat of harm or restraint to you or another if you don't perform.
